Dear Parents,

The association Hilfe von Mensch zu Mensch e.V. offers a leisure programme for children aged 6-10 during the summer holidays as part of the "Special Holiday Care Programme".

The programme is primarily aimed at children whose parents have already used up their annual leave due to the corona pandemic. These children are given priority; remaining places can also be given to other children. The children receive drinks, fruit, snacks and lunch. The participation fee is 20€ per week and child, the amount is to be brought in cash on the first day of the holiday week. Up to one week before the project week, the place can be cancelled without costs. Up to one day before the start of the project, 50% of the participation fee must be paid. In case of cancellation on the first day of the project, the full participation fee must be paid.
